

RECENT AOU CHECK-LIST CHANGES AFFECTING NEW MEXICO BIRDS

INTRODUCTION

The recently-published "43rd Supplement" to the American Ornithologists' Union (AOU) *Check-list of North American Birds* (Auk 119:897-906, 2002) is the second Supplement to appear since the publication of the 7th Edition of the AOU Check-list in 1998. The Supplement contains several changes that affect New Mexico birds; these primarily involve English and/or scientific name changes resulting from taxonomic splits or other considerations. The Supplement does not alter the number of bird species attributed to New Mexico.

SUMMARY OF CHANGES

The genus *Ajaia* is merged into *Platalea*, hence Roseate Spoonbill becomes *Platalea ajaja*.

The authority for the recently split Gunnison Sage-Grouse, *Centrocercus minimus*, is corrected to Young et al. (Wilson Bull. 112:446, 2000); this is the species that historically occurred in New Mexico.

The genus *Porphyrula* is merged into the Old World *Porphyrio*, hence the Purple Gallinule becomes *Porphyrio martinica*.

The common and widespread snipe of North America becomes Wilson's Snipe, *Gallinago delicata*, a species now recognized as distinct from the Old World *Gallinago gallinago*.

For reasons of grammar, the name of the Red Phalarope becomes *Phalaropus fulicarius*, *not fulicaria*.

The better indicate affinities, the English name for *Euptilotis neoxenus* is changed from Eared Trogon to Eared Quetzal. The species is hypothetical in New Mexico, based on one seen and heard (and detailed!) 13 June 1979 just north of the Animas Mountains, Hidalgo County.

As a result of DNA analysis as well as similarities in behavior, molts, and plumages, the monotypic genus *Guiraca* is merged into *Passerina*, hence the Blue Grosbeak becomes *Passerina caerulea*. Reflecting genetic relationships, the sequence of the five New Mexico *Passerina* species is: Blue Grosbeak, Lazuli Bunting, Indigo Bunting, Varied Bunting, and Painted Bunting.

A change not directly affecting New Mexico birds but of interest to New Mexico birders is the splitting of Black-crested Titmouse, *Baeolophus atricristatus*, as a species distinct from Tufted Titmouse, *Baeolophus bicolor*.

Finally, several records of the Piratic Flycatcher, *Legatus leucophaius*, in the United States are formally recognized, including the one documented in New Mexico at Rattlesnake Springs 1-7 September 1996. Unfortunately, the 43rd Supplement erroneously gives the location as "Lea County" rather than Eddy County.



NMOS Research Grants

The NMOS is now offering grants to help support research on New Mexico birds. Two grants of up to \$XXX each may be awarded. The criteria for the grants are: 1) the grant money must be spent while conducting research on birds in New Mexico; 2) a short research proposal (2 pages maximum), plus names of three references must be submitted describing the nature of the project and how the allocated funds are to be spent (on gas, tape recording, specific equipment, etc.); 3) a recipient must either present their findings at an annual NMOS meeting or have an article on their research published in the NMOS Bulletin; and 4) research proposals must be received by March 1, 2003. REPORTING NEW MEXICO BIRD OBSERVATIONS

It is common knowledge that birders have added greatly to our understanding of the bird life of New Mexico. In fact, birders now account for the majority of new data on species distribution and field identification of North American birds generally. However, unless field observations are properly documented and submitted for consideration, they have no way of becoming part of the ornithological record. For New Mexico, bird records are published seasonally in *North American Birds*, the American Birding Association's journal (now in its 56th year) dedicated to documenting the continent's bird life, and subsequently in the *NMOS Field Notes*, published quarterly by the New Mexico Ornithological Society.

Sandy Williams is New Mexico's Regional Editor for *North American Birds* as well as Editor of *NMOS Field Notes*; he also maintains the NMOS Archives, including all written bird sighting submissions as well as the New Mexico Photo-Tape File, which includes prints, slides, audio tapes, video tapes, digital images, and compact disks. The year is divided into four seasons (see below), and observers are asked to submit their records to Sandy promptly at the close of each season. All submissions become part of the NMOS Archives; even if all your reports are not published, they remain on file and available for future workers.

All New Mexico birders are encouraged to submit their sightings, especially of uncommon species, nesting birds, and early, late, or out-of-range birds. Please submit your records in taxonomic order and make sure all records include date, exact location, numbers of birds, age and sex/color morph, if applicable, and name(s) and contact information (including e-mail address) of observer(s).


Please provide details for unusual species. Details are usually needed for sightings of birds appearing in light-faced type in the NMOS *Field Checklist of New Mexico Birds*. Written details and other documentation of very rare species will be circulated to the New Mexico Bird Records Committee for evaluation. Written details may be submitted on a report form (available by mail from Sandy or electronically from the NMOS web page), although any written format is acceptable. If photographs or slides are submitted, please include on the photo/slide your name, date the picture was taken, and the exact location.

Below are the seasons for reporting New Mexico bird observations. Don't procrastinate--send your reports as soon as possible after the close of a reporting period.

Autunm August 1-November 30 (= 4 months)
Winter December 1-February 28 (= 3 months)

Spring March 1-May 31 (= 3 months) Summer June 1-July 31 (= 2 months)
