NMOS 46th ANNUAL MEETING CALL FOR PAPERS – GENERAL SCIENCE SESSION

The 46th Annual Meeting of the New Mexico Ornithological Society will be held on Saturday, 12 April 2008 at the Vagabond Inn Executive in Albuquerque, New Mexico. Oral presentations will be allotted 15 minutes, with an additional five-minute period for questions. Papers may range from technical reports of original research to general observations. Poster presentations are also encouraged. Poster sizes should be no larger than 91 cm H x 122 cm W.

Please submit abstracts containing the following information:

- TITLE (in all capital letters) of no more than 20 words.
- Names and addresses of author(s) in the following form:

- Body of abstract as one single-spaced paragraph, not to exceed 250 words.
- Include e-mail address and/or phone number of presenting author.

Please submit your abstract in the body of an e-mail, not as an attachment. This will prevent any problems with incompatible word processing formats. Abstracts should be e-mailed to the Session Chair, Martha Desmond (Phone: 505-646-1217), at mdesmond@nmsu.edu on or before 12 March 2008.

Abstracts for both the NMOS General Science Session and the Gray Vireo Symposium will be distributed at the meeting and will be published in the *NMOS Bulletin*. In addition, expanded abstracts from invited papers in the Gray Vireo Symposium will be published in a proceeding by the New Mexico Department of Game and Fish.

NMOS RESEARCH GRANTS

The New Mexico Ornithological Society is again pleased to announce the availability of two \$1000 research grants, through the Ryan Beaulieu Research Grant Program, to support research on New Mexico birds.

The criteria for the grants are: the grant money must be spent while conducting research on birds in New Mexico; the recipient must either present a paper based on the research at an annual NMOS Meeting or submit an article based on the research to the NMOS Bulletin; and preference will be given to student applicants.

A short research proposal (two pages maximum) must be submitted describing the nature of the project and how the funds would be spent (e.g., on gas, tape recording, specific equipment, etc.). Each proposal should include two letters of reference, one of which should be from a graduate advisor if the applicant is a graduate student. References should comment on the applicant's commitment to New Mexico ornithology and ability to design and carry out creative, independent research. Research proposals must be received by 12 March 2008. Please submit your electronic proposal, with "NMOS Grant" in the subject line, to:

MANUSCRIPTS NEEDED FOR NMOS BULLETIN

New Mexico Ornithological Society members are encouraged to submit articles of scientific merit concerning the distribution, abundance, status, behavior, and ecology of the avifauna of New Mexico and its contiguous regions. Articles received for consideration in the *NMOS Bulletin* are subject to peer review and editing. Published articles are noted in major abstracting services. Please submit articles in double-spaced electronic format, such as a Microsoft Word document, by e-mail to the Editor (see inside front cover). Refer to recent issues of the *Bulletin* for examples of style.

NMOS FIELD NOTES

NMOS Field Notes is published quarterly, and provides a seasonal overview of the changing patterns of New Mexico's birdlife, including unusual records, breeding and wintering range changes, and changes in seasonal occurrence and migration patterns.

All individuals interested in birds in New Mexico are encouraged to submit their observations to *NMOS Field Notes*. Especially solicited are records of uncommon species, nesting birds, and early, late, or out-of-season/range birds. Records should be submitted in taxonomic order and should include species name, date, exact location, numbers of bird(s), age, sex, and color morph (if applicable), and name and contact information (including e-mail address) of observer(s). Remember, unless field observations are properly documented and submitted for consideration, they have no way of becoming part of the ornithological record. Note that reporting birds to Rare Bird Alerts or listservs does not constitute submission to *NMOS Field Notes*.

Please provide details for unusual records. Details are usually needed for sightings of birds appearing in light-faced type in the NMOS Field Checklist of New Mexico Birds (see: www.nmbirds.org/nmcheck.html). Written details and other documentation of very rare species will be circulated to the New Mexico Bird Records Committee for evaluation. Written details may be submitted on a rare bird report form (available from the Editor or electronically from links on this webpage: www.nmbirds.org/nmbrc.html), although any written format is acceptable. If photographs are submitted (electronically or as slides, prints, or video), please include with the photograph the name of the species in question, date the picture was taken, the exact location, and photographer's name.

The four reporting periods correspond to the four seasons of the year, which are:

- Winter (1 December 28/29 February)
- Spring (1 March 31 May)
- Summer (1 June 31 July)
- Autumn (1 August 30 November)

Please submit reports as soon as possible after the close of a reporting period.

NEW MEXICO RARE/UNUSUAL BIRD REPORTING

The following is a listing of information requested when reporting observations of rare or unusual birds in New Mexico. This listing is also available as an electronic form that may be used flexibly and need not be used at all (available at: www.nmbirds.org/nmbrc.html). Forms may be printed in black ink or submitted electronically. Attach available drawings, photographs (electronic, or slides, prints, video), copies of field notes, etc.; include all photos of obscurely marked species. When completed, mail to: Sartor O. - 1. Common or scientific name.
- 2. Number of individuals, sexes, ages, general plumage (e.g., 2 ad. males in breeding plumage).
- 3. Locality (include County and distance from nearest named town).
- 4. Date(s) when seen.
- 5. Time(s) of day when seen.

- 6. Reporting observer (include middle initial, address, and e-mail address).
- 7. Other observers accompanying reporter who also identified the bird.
- 8. Other observers who independently identified the bird.
- 9. Light conditions (position of bird in relation to shade and to direction and amount of light).
- 10. Optical equipment (type, power, and condition).
- 11. Distance to bird.
- 12. Duration of observation.
- 13. Habitat (general and specific).
- 14. Behavior (flying, feeding, resting, etc.; include and stress any habits used in identification).
- 15. Description (include only what was actually seen, not what "should" have been seen. Include if possible: total length; body bulk; bill, eye, and leg characteristics; color and pattern of plumage, etc. Stress field marks).
- 16. Voice.
- 17. Similar species (include how they are eliminated by your observations).
- 18. Photographs (Was it photographed? By whom? Attached?).
- 19. Previous experience with this species.
- 20. Aids: List books, illustrations, birders, etc., used in identification a) at time of observation; b) after observation.
- 21. This description was written from: notes made during observation; notes made after observation; memory.
- 22. Are you positive of your identification? If not, explain.
- 23. Signature of reporter, along with date and time of writing of this account.

It is emphasized that a request for documentation is not an affront, but is an effort to substantiate a record by obtaining concrete evidence which may be permanently preserved for all to evaluate.


