#### MINUTES OF THE ANNUAL MEETING

The meeting opened on 24 March 1979 at 8:45 a.m. in the Biology Building, University of New Mexico, Albuquerque, with a slide show presented by John Egbert. The business session was called to order at 9:30 by President Bruce J. Hayward. Forty-two people were in attendance. The Minutes of the 1978 Annual Meeting were corrected and approved. Chuck Hundertmark, Secretary, reported that this was the last day the <u>Revised Check-list of Birds of New</u> <u>Mexico</u> would be available at \$1.50 first copy to members, in the future, the price will be S2.50 per copy. Treasurer Jim Sands reported:

The loan of \$1250 from Sangre de Cristo Audubon for publication of the <u>Revised Check-list of Birds of New Mexico</u> has now been reduced to \$450 as of January 11, 1979. The Nominating Committee, Burt Lewis, Pat Snider, and Bill Turner, proposed the following slate of officers for 1979–1980: John P. Hubbard, President; James R. Travis, Vice-President; Mary Lou Arthur, Secretary; Ross L. Teuber, Treasurer; Charles A. Hundertmark and Alan Nelson, Directors-at-large. Election was unanimous. Announcement was made that two issues of <u>Field Notes</u> are in the process of being completed. Also the, nest record cards will soon be available to members. Jim Travis reported that the 10-year index to the <u>Field Notes</u> is completed. Publication of this will be in the near future. John Hubbard discussed the breeding bird census scheduled for the last of May and June. He encouraged members to take part in these counts and to contact him about routes. Dave Lange announced the Southwest

Conference of the National Audubon Society will be held between June 4-11, 1980 at Ghost Ranch. This will be a series of meetings and field trips. Information is needed from the members for good birding areas within the state. He would like to compile regional brochures for use at this time. Pat Snider offered to help on this project. Bert Lindsay gave a short talk on the Friendship Force, a cultural exchange group going to Korea in June. The cost is less than \$400 for two weeks there. He is the State Chairman and is encouraging birders to go. More Information can be obtained by calling him at 299-7454. Jim Travis led in a round of applause for Bruce Hayward and Jim Sands, in appreciation of their service to the Society. The meeting was adjourned at 10:15am.

The morning session was concluded with Transect Studies of New Mexico Birds: "Roadside Raptor Counts" - John Hubbard and "U.S. Fish and Wildlife Service Breeding Bird Counts" - James Travis. In the afternoon, papers were given by: Tom Marr - "Foraging Behavior of Nesting Cactus Wrens"; Michael Delasanto - "Breeding Ecology of the Black-throated Sparrow"; Rex Wahl - "Experimental Investigation of Some Aspects of Mobbing Behavior"; James Travis - "Analysis of Vocalizations in <u>Empidonax</u> Flycatchers"; James Travis - "Endangered Birds of Hawaii"; Bruce Hayward - "South African Birds"; John Egbert - "An Instance of Bird Predation by an American Kestrel", and concluding, James Bednarz -"The Red-shouldered Hawk Population in Iowa". ## NMOS BREEDING RECORD PROGRAM FIVE-YEAR ANALYSIS: 1970-1974

Since 1965, the New Mexico Ornithological Society has maintained a state breeding record program. In this paper, I analyze contributions of this program and update the summaries which have appeared in previous NMOS Field <u>Notes</u> (Hundertmark 1968, 1969). Since the 1969 breeding season, our nest record files have expanded rapidly, and coverage by species, habitat type, county, and altitude have all improved. There remain, however, many areas for which data are needed.

By 1969, records for 177 species of breeding birds had been submitted to the NMOS breeding record program (Hundertmark, 1969). Since then, records for 45 additional species have been submitted, bringing the total number of species as of February 1975 for which we have recent breeding records to 222. Notable among the additions to the list since 1969 are Western Grebe, Little Blue Heron, Cattle Egret, Eastern Bluebird, and Cassin's Finch.

Along with the addition of species, improved geographical coverage of the state is indicated since 1969. Over 100 records have been submitted for each of 15 counties, compared with 7 counties in the same category at the end of 1969. At the other end of the spectrum, only 8 counties remain for which we still have fewer than 50 breeding records. This compared with 19 counties with fewer then 50 records at the end of the 1969 nesting season. Coverage of the eastern part of the state improved considerably, with conspicuous increases in Quay, DeBaca, Roosevelt, and Guadalupe counties. Coverage in Curry County, however, remained minimal. The northeastern counties of Harding, Colfax, and Mora also received minimal coverage. In Taos, Santa Fe, and San Miguel counties, coverage declined somewhat from the pre-1969 level.

Coverage of the higher elevations in the state has also improved since 1969. From 1970 through 1974, breeding records were distributed by altitude ranges

(Table 2). Prior to 1969. we had almost no records from above 7000 feet elevation. Our coverage by altitude probably closely reflects the areal proportion of altitude ranges in the state now. Nevertheless, some of the major gaps in our records remain in the higher altitudes. This probably reflects the greater difficulty in locating nests in forested areas, compared with lowlands where nests may be more conspicuous in open vegetation, improved coverage of higher altitudes has added recent records for such species as Gray Jay, MacGillivray Warbler, and White-crowned Sparrow.

Finally, our coverage by type of habitat has substantially improved since 1969. For example, Improved coverage of eastern counties has resulted in improved coverage of grassland habitats. We have also greatly increased our coverage of marshlands, where major gaps existed in our pre-1969 records. And, as already noted, our coverage of mountain habitats has increased substantially since 1969.

As ornithological work in New Mexico progresses, I believe the value of the breeding record program will increase. For example, I think that the breeding record files will serve as an increasingly more important source of data in the preparation of environmental assessments. In fact, those of us who have the opportunity to review those assessments should insist that government agencies use this data source. The breeding record files should help us accurately assess the status of a growing number of breeding birds in the state.

Obviously, we will better serve all of these purposes if our breeding record coverage continues to improve, as it has over the past five years. While all records add to our coverage, work directed toward remaining gaps in the overall record will be particularly useful. We need current data on several species of ducks which probably still nest on northern lake areas. We need records on a number of mountain species, particularly those nesting in the spruce-fir zone or higher. We also need data on several species which nest in limited areas such as the Bobwhite and Mexican Chickadee. And finally, we need more data from a number of counties which remain poorly surveyed.

## NEW MEXICO'S ENDANGERED BIRDS

By John P. Hubbard

New Mexico's state endangered species list has been revised and reissued as Regulation No. 599, effective 25 May 1979. Birds now listed as endangered in New Mexico are:

<u>Group I</u> -- Gray Hawk, Caracara, Peregrine Falcon, Aplomado Falcon White-tailed Ptarmigan, Sharp-tailed Grouse, Sage Grouse, Coppery-tailed Trogon, Buff-breasted Flycatcher, and Sulphur-bellied Flycatcher.

<u>Group II</u> -- Olivaceous Cormorant, Mississippi Kite, Black Hawk, Bald Eagle, (Mexican) Turkey, Whooping Crane, (inland) Least Tern, Buff-collared Nightjar, Violet-crowned Hummingbird, White-eared Hummingbird, Broad-billed Hummingbird, Red-headed Woodpecker, Gila Woodpecker, Thick-billed Kingbird, Beardless Flycatcher, Bell Vireo, Varied Bunting, Yellow-eyed Junco, and McCown Longspur.

Group I species are those whose prospects of survival or recruitment in New Mexico are in jeopardy, a definition that is roughly equivalent to the federal term "endangered." Group II species are those the survival or recruitment of which could become jeopardized within the near future, which is roughly the same as the federal "threatened." Most Group I species on the above list have suffered notable declines in New Mexico, and some of the species may even be extirpated there, e.g., Sharp-tailed Grouse. Group II species are generally in better straits, but some catastrophic event could shift them to Group I status, e.g., massive destruction of habitat.

One will note that most of the species listed above cannot really be considered to be endangered or threatened in the broad sense, that is, their survival is not jeopardized or apt to become so over a large part or all of their total ranges. In other words, outside of New Mexico most of these species are surviving adequately, and some are even common and thriving elsewhere. However, the law under which species are listed as endangered In New Mexico, i.e., the state's Wildlife Conservation Act, requires that the Department of Game and Fish focus on a species' status only within the state, hence many peripheral or otherwise limited populations of birds become candidates for listing. In some ways this may seem unnecessary, but on the other hand, if each state does not take steps to preserve its own biological diversity, then the job may not get accomplished.
